The DEAC Nominating Committee is pleased to announce the following candidates for the DEAC Board of Directors:

The Nominating Committee has worked closely with the Board of Directors to review and recommend candidates for the DEAC Board of Directors to serve as institution members. Throughout its deliberations, the Nominating Committee took into consideration the appropriate involvement of DEAC's communities of interest as well as the diversity of DEAC's membership and stakeholders. In addition, the Nominating Committee's work involved a meaningful assessment of the organization's present and future leadership needs reflective of mission; attention to continuity and orderly succession of the organization's leadership; and upholding a practice of good governance. DEAC is holding the election to fill two institution representative positions on the board of directors. The three-year terms for current institution representatives, Dr. Barron and Mr. Reeves will end on March 31, 2018. The Nominating Committee welcomes their candidacies to serve a second term and welcomes Mr. Curd as a new candidate for institution representative on the board of directors.

An electronic ballot will be available to all DEAC members beginning on April 23, 2018 at the Annual Business Meeting and continuing through 6:00 pm eastern time on April 24, 2018. Candidate – Institution Member DEAC Board of Directors



I cannot understate how humbling it was when I was appointed to fill a vacancy on the Board two years ago. Since that time, I have served as a DEAC Commissioner, the Academic Review Committee Chair, as Vice Chair of the Board of Directors, and as acting Chair. My first term was a master class in thoughtful deliberation, accreditation standards, and the unique value of DEAC and its institutions. I often joke that I 'found my people' when I took on this role. I am proud of my work on your behalf.

The variety of DEAC institutions requires a range of experience and perspectives on the Board. While I believe I am a diligent advocate for all institutions, I am often the loudest voice for

smaller institutions; Dunlap-Stone University is a small, family-run and non-Title IV institution with a handful of degree and certificate programs. We were first accredited in 2003. As Chief Academic Officer, I wear many hats: accreditation, curriculum, assessment, licensure, faculty management, instructor, and special projects. I thrive on the variety and the chance to try new things with the goal of continuous improvement. My heart lies in teaching, curriculum development, and distance education best practices, evidenced by the presentations I have made at Annual Conference and Fall Workshops and my publications.

Helping students achieve their educational goals while working with organizations that support education has been the central thread of my career over the last 20 years. I have worked with traditional and non-traditional students in a variety of settings: overseeing academics and operations for for-profit and non-profit organizations, managing editorial content for a school-age publishing company, working in college admissions and public relations, and in other higher education settings. I completed both my EdD in Higher Education Administration and a MEd in Adult Education as a distance learner, contrasted by a very traditional liberal arts undergraduate experience. I know the non-traditional students many of our institutions serve because I was one.
