On September 5, 2014, DETC invited nominations to fill one vacant position on the Nominating Committee. The Committee is responsible for the screening of nominees and selection of candidates for election to the Board of Directors. The DETC will open electronic voting for the Nominating Committee election at the Business Meeting on October 6, 2014. Electronic voting will remain available until 5:00 PM eastern time on Tuesday, October 7, 2014. Instructions for electronic voting will be distributed to all DETC-accredited institutions via email on October 1, 2014. Each DETC-accredited institution is entitled to one vote. DETC will announce the results following the Accreditation Workshop.

Dr. Matthews, DETC's Executive Director, encourages members to participate in the voting process whether or not they are able attend the Business Meeting. "Constituting the Nominating Committee is an important first step in assuring candidates for election to the DETC Board of Directors possess the breadth and depth of experience needed for effective leadership and governance of our organization," Matthews said.

Dr. Paul Eidson

Dr. Paul Eidson, a native of South Carolina, is the President and CEO of Apollos University, He is one of the founders of Apollos and has served in various roles since 2004. Dr. Eidson earned his BS degree in Business Administration from The Ohio State University, his MBA from Western New England College, and his Ph.D. from Capella University. His background includes 23 years in the United States Air Force and as a Foreign Military Sales program officer. Dr. Eidson was also a director of Subcontracts for the International Space Station program working for Boeing under its NASA contract. Dr. Eidson is an author, lecturer, and motivational speaker. He has actively designed academic programs as well as taught college level classes for over 20 years. He has extensive experience in teaching in the traditional model as well as in the virtual distance education model. Dr. Eidson is active in professional organizations and has served in leadership roles such as the National Director and Chapter President of the National Contract Management Association. Dr. Eidson is a Certified Purchasing Manager (CPM) through the National Association of Purchasing Management, Inc. His awards include Sigma Beta Delta Membership, Air Force Accommodation Award, National Management Association Manager of the Year Award (Chapter 284), and Finalist for the Air Force Association Abrahamson Award. Dr. Eidson has served on numerous DETC evaluation teams and is a member of the Research and Educational Standards Subcommittee and the Business Standards Subcommittee.

Dr. Leslie Gargiulo

Dr. Leslie Gargiulo is currently the Chief Operating Officer and Chief Academic Officer of the California Intercontinental University in Diamond Bar, CA. Dr. Gargiulo was the Chief Academic Officer and Executive Vice President of Product Development for Ashworth College from 2010 to 2014. She also served as the Academic Dean at Allied American University from 2008 to 2010 where she implemented academic strategic plans to create and launch the AAU 100% online university.
